

TWISTED ESCAPE ROOMS

PARTICIPANT WAIVER, RELEASE OF LIABILITY & RULES OF PARTICIPATION

1. ASSUMPTION OF RISK & RELEASE OF LIABILITY

I voluntarily assume all risks of participating in activities at Twisted Escape Rooms ("TER"), including without limitation: low lighting, confined spaces, sudden sounds, physical puzzle elements, simulated darkness, and strobe/lighting effects. I expressly release Twisted Escape Rooms, its members, representatives, and employees from any and all claims — including claims arising from the negligence of Twisted Escape Rooms, its members, representatives, or employees — for any injury, loss, or damage sustained during participation. Persons with heart conditions, anxiety disorders, PTSD, light/sound sensitivity, or who are pregnant are recommended to consult a physician before participating and do so entirely at their own risk.

2. HEALTH & CONDUCT

I confirm I am not under the influence of drugs, alcohol, or any substance that may impair safe participation. Staff may, at their sole discretion, determine that any participant's continued participation is unsafe and remove them from the premises by any lawful means. I agree to be financially responsible for any deliberate damage to property, including objects broken or removed from the rooms.

3. ROOM RULES

Sessions last 60 minutes; participants may exit at any time. Nothing in the rooms requires breaking, climbing, forcing, lifting, or removing. Ceiling, flooring, and wall coverings are not to be disturbed. Electrical outlets are live — do not touch. Any group exhibiting risky or disruptive behaviour will have their session terminated without refund.

4. PHOTOGRAPHY & RECORDING

Photography and video recording inside the escape rooms is strictly prohibited and will result in immediate session termination without refund. Lobby photography is welcome. TER reserves the right to use photographs and images from your visit for promotional purposes, and by signing you grant this consent.

5. CONFIDENTIALITY

I agree not to disclose room layouts, puzzles, clues, solutions, codes, or room secrets to others, whether in person or online.

6. ELECTRONIC ACCEPTANCE

If accepting digitally, clicking "I Accept" constitutes my legally binding electronic signature under Washington's Uniform Electronic Transactions Act (RCW 1.80) and the federal E-SIGN Act. My IP address and acceptance timestamp will be recorded as part of this waiver record.

7. IDENTITY VERIFICATION & ADMISSION

Bookeo will require you to input your full name, address, and contact details during booking. Upon arrival, TER requires you to present your in-date valid government-issued ID in person to reception staff for inspection. Photo ID is preferred. This MUST match the name and address used to make the booking. Without valid ID from the booking member, no admittance to any room will be given and you will forfeit the booked slot with no refund — no exceptions. No other member of the group can deputise for you should you forget to bring your ID. This is for the safety of the company and its staff. Just as you would not allow a contractor into your home without ID, we apply the same principle — this is neither restrictive nor draconian. Walk-ins will be subject to the same ID requirements and binding conditions of waiver made available when booking.

This agreement is governed by the laws of the State of Washington. Any disputes shall be resolved in Clark County, Washington.
